Introduction

MOSA - Medical Oxygen Society of the Americas is seeking support from the international community in conducting a ground-breaking *Feline Leukemia (FeLV) Case Study ... to find a cure for FeLV*. MOSA headquarters is located in West Palm Beach, FL, U.S.

The goal of the *Case Study* is to determine the efficacy of international scientifically recognized alternative medicine protocols in the treatment of the supposed "incurable" **Feline Leukemia (FeLV) "retrovirus"**.

The initial *Case Study* will involve 13 felines who have *previously tested positive* for the "elevated presence" of the p27 core protein bio-marker using a standard Veterinary protocol **ELISA Blood Test**.

The ELISA Blood Test for the p27 bio-marker is considered (by the mainstream U.S. Veterinary industry) to be a key indicator identifying the **Feline Leukemia (FeLV) "retrovirus"** is present in a feline.

All test results will be verified by independent laboratory analysis.

4. MOSA will be responsible for undertaking all case study tasks with respect to the planning, organization and administrative work (data analysis, reports, presentations and related materials) ... **accept when Qualified Veterinary Intervention** is required.

5. The 13 FelV Case Study Felines are located in their very own clean, spacious "cat house" on private property located in Jupiter, FL. Their guardian is a very caring owner, experienced providing beneficial daily nutrition and hygiene protocols, and administering oral and injection medication. These felines are in safe hands and well taken care of.

6. MOSA welcomes the co-operation from Laboratories or Institutes willing to donate the time in analyzing the necessary Blood Tests required through the course of the study, or a reduction in laboratory costs for the required case study blood tests only.

According to the **Merck Pharmaceuticals Veterinary Manual:**

“Despite the widespread use of vaccines, **Feline Leukemia Virus (FeLV)** remains one of the most important causes of morbidity and mortality in cats.”

Feline Leukemia (FeLV) “retrovirus” is considered “*incurable*” ... according to the mainstream U.S. Veterinary industry, using the best of “*allopathic medicine protocols*”.

However, a wealth of scientific research, in addition to innumerable credible U.S. and international Veterinary experiences spanning several decades ... suggest otherwise:

Feline Leukemia is “diagnosed” using standard in-house veterinary blood tests which test for “elevated levels” of the **p27 protein** which “allopathic medicine suggests” is an indicator for the presence of the **Feline Leukemia “retrovirus”**.

However, “**elevated protein levels**” can be caused by many other factors, including stress, nutritional deficiencies, exposure to common chemicals, response to a common cold virus, natal antigens, and vaccine reactions / bio-markers ... to name but a few.

Kittens that test positive by ELISA should be re-tested when they're older than 16 weeks of age, when the mother's (natal) antigens should be out of their system.

A far too common practice for U.S. Veterinarians is in recommending euthanasia too soon after a feline tests positive for "elevated levels of the p27 protein". Alarming, countless felines (including healthy felines) will be *euthanized* that very same day!

Sadly, *this occurs* with little consideration to other signs or tests of good health, the absence of other symptoms ... and the known unreliability of the ELISA tests.

In addition, despite independent laboratory blood testing being recommended to confirm the FeLV diagnosis ... this recommendation is not always followed.

How would you feel if a "50% accurate blood test" for "elevated protein levels" ... sentenced you to death (the same day within hours!) while completely ignoring the numerous proven alternative medicine treatments ... to cure your condition?

In a brief to the [NATO Blood Committee](#), the [Surgeon General of the Canadian Armed Forces](#) announced that... "[a 3-minute Ozonation \(O3/O2\)](#) of serum spiked with one million **HIV-1** particles per milliliter would achieve virtually [100% viral inactivation](#)."

The study also found that the ([Ozonation O3/O2](#)) procedure would destroy several other lipid-encapsulated viruses (for example, **FeLV**) including [Simian Immunodeficiency Virus \(SIV\)](#) and various other viral strains of interest to **VETERINARIANS**:

(Oakville, Ontario, Canada), Medizone International Inc., New York, and [Cornell University, Ithaca, NY](#).

Two teams of US virologists have used comparable (**O3/O2**) gas-diffusion techniques to **confirm the Canadian findings**.

(N.B. **FeLV, HIV, and FIV** all belong to the same virus family ... "**retroviruses**").

***In United States:* Like HIV, the FeLV virus is a lipid-enveloped virus.** - Fred W. Scott, DVM, PhD - Interim Director, Cornell Feline Health Center (Virology) - www.vet.cornell.edu/

***In United States:* Medical Ozone** has previously been shown to possess **potent antiviral activity**, especially when used against lipid-enveloped viruses (For example, **FeLV**). For this reason we investigated the use of ozone as a potential anti-**HIV-1** agent.

It is readily apparent that **Medical Ozone** may be of use in rendering blood products, both proteinaceous and cellular, free of **HIV-1** and **other infectious agents**.

Medical Ozone was found to inactivate **HIV-1 virions** in a dose-dependent manner. The data indicate that the antiviral effects of ozone include viral particle disruption, reverse transcriptase inactivation, and/or a perturbation of the ability of the virus to bind to receptor on target cells.

Medical Ozone treatment offers promise as a means to inactivate human retroviruses in human body fluids and blood product preparations. - The American Society of Hematology (1991)

In Germany: Dr. Horst Keif is curing **AIDS** victims in the Munich area of West Germany, by hyper-oxygenating their blood with **Medical Ozone**, which destroys the **HIV virus** on contact.

As the **Ozone (O3) molecules** dissolve into the blood, they give up their third oxygen atom, releasing considerable energy, which **inactivates all lipid-envelope viruses (FeLV)**, while leaving the blood cells unharmed. - Dr. Richard Wilhelm B.Sc

HIV Antiviral Effects of Hyperbaric Oxygen Therapy (HBOT).

Reillo MR, Altieri RJ.- Lifeforce Hyperbaric Medical Clinic, Baltimore, MD, USA.

Researchers have speculated that **hyperbaric oxygen therapy (HBOT)** has an **antiviral** effect in **HIV** infection.

To determine HBO's antiviral effect, the authors performed ex vivo and in vivo quantitative assays on HIV-infected plasma and peripheral blood mononuclear cells (PBMCs) at baseline and after treatment. The authors also HBO treated uninfected PBMCs and then exposed them to HIV at ambient pressure.

HIV viral load was decreased in the infected cells, and few viruses entered uninfected PBMCs exposed to HBO. The results of this study support the theory that HBO has an antiviral effect.

HIV: Reactive Oxygen Species, Enveloped Viruses and Hyperbaric Oxygen.

Baugh MA.- BaroAntiviral, San Diego, California 92103, USA.

This paper demonstrates *there are many examples in the literature of contradictory data concerning reactive oxygen intermediates (ROIs)...* and their enhancement or diminution of viral replication. Nevertheless, ROIs repeatedly have been shown to be **virucidal** against **enveloped-viruses** like the human immunodeficiency virus (**HIV**).

Hyperbaric oxygen therapy (HBOT) increases the production of ROIs throughout the body, leaving no safe harbor for the virus to hide outside the genome. This technique already has been tried on acquired immune deficiency syndrome (**AIDS**) patients, with **exciting results**.

Historically, the biggest setback to demonstrating HBO's antiviral effects has been the investigator's folly of studying non-enveloped viruses or failing to initiate ROI production. ROIs specifically attack areas of unsaturation occurring in polyunsaturated fatty acids of cell membranes and viral envelopes.

Moreover, it consistently has been shown that a peroxidized viral envelope breaches, and a breached viral envelope causes viral disintegration.

The Effectiveness of Intermittent Hyperbaric Oxygen Therapy (HBOT) in Relieving Drug-Induced HIV-Associated Neuropathy.

Jordan WC.- Department of Internal Medicine, Charles R. Drew University of Medicine and Science, King-Drew Medical Center, Los Angeles, California 90059, USA.

This 3-month study evaluated the effects of **hyperbaric oxygen** on drug-induced neuropathies in 22 patients with human immunodeficiency virus (**HIV**).

All patients included in the study had been taking an antiretroviral medication for at least 12 months and had subjective symptoms of numbness or tingling, lethargy, and a decrease in deep tendon reflex. Patients with an active substance abuse history or Kaposi's sarcoma were excluded.

Of the 20 patients who completed the series, 17 had significant improvement, 2 had a demyelinating disorder that may have affected the outcome, and 1 had no change.

Hyperbaric Oxygenation in the Combined Therapy of Infectious Diseases.

Ivanov KS, Liashenko II, Kucheriavtsev AA, Finogeev IP, Zhdanov VP, Khodzhaev GA. Klin Med (Mosk). 1992 Jan;70(1):90-2.

Hypoxia plays an important role in pathogenesis of infectious diseases. Therefore, its correction is an essential factor in pathogenetic anti-bacterial treatment.

Hyperbaric oxygenation (HBO) as a leading method in current anti-hypoxic therapy was studied in combined medication for typhoid, diphtheria, meningococcal infection, **viral hepatitis**.

HBO sessions were given to 331 patients, 363 controls did not receive HBO.

Utilization of HBO provided much better saturation of blood with oxygen, eliminated metabolic disorders, warranted favorable course and outcomes of the diseases.

The use of Hyperbaric Oxygenation in Treating Viral Hepatitis B and the Reaction of the Blood Leukocytes

Gabrilovich DI, Musarov AL, Zmyzgova AV, Shalygina NB.- Ter Arkh. 1990;62(1):82-6.

A total of 75 patients with **virus hepatitis B** of medium gravity were examined for the effect of **HBO** on the clinical course of the disease and blood leukocyte reaction. This reaction was tested on the basis of a complex of rosette-forming and cytochemical tests.

HBO was found to produce a favourable effect if used at the early stages of the treatment (the first week of hospitalization). The effect consisted in significant reduction of the rate of exacerbations and residual phenomena.

HBO provoked a decrease in the content of T and B lymphocytes by the 10th session of the treatment.

A close relationship was revealed between **HBO** efficacy and the initial level of functional metabolic activity of leukocytes.

The use of **HBO** was always accompanied by the rise of that activity during the treatment.

The use of **HBO** at later times of the treatment (weeks 4-5) did not produce any well-defined clinical effect.

*Thus, **HBO** (8-10 sessions, pressure 1.5 absolute atmosphere, exposure 45 min) may be indicated as a prophylactic measure in respect of an unfavourable disease course with regard to the patients' selection on the basis of a complex of cytochemical tests.*

Calusa Veterinary Center in Boca Raton, Florida, was among the first animal hospital in the nation to acquire a **hyperbaric oxygen chamber**, which is more compact than ones for humans.

It reduces swelling and inflammation, eases pressure and edema caused by head or spinal cord injuries, stimulates new blood vessel formation in healing tissues, improves control of infection, and promotes wound healing.

Antibiotic, Anti-Microbial, Immune Deficiencies

Colloidal Silver is a safe and proven medicine that may be used internally and externally. In the nineteenth century, **Colloidal Silver** - also known as *Argentum colloidal*, *Argentum crede* and *collargolum* - was a prominent treatment for everything from colds to skin infections.

Extensive international scientific evidence points to the fact that **Colloidal Silver** *safely destroys all types of virus* including the *HIV retrovirus*. It is strongly suggested by research scientists, such as **Dr. Gary Smith** and others, that "*silver ions are essential to the immune system*".

In United States: In the 1970's and 80's ... the late **Dr. Robert O. Becker, M.D.** conducted ground-breaking research at **Syracuse Medical University, New York, U.S.** using tiny, electrically generated, sub-microscopic silver particles.

In this study, nine individuals who were near death were divided into two subgroups. One group suffered from *HIV* and a *terrible Candida infection*. The other group suffered from both *HIV* and an extreme form of *malnutrition* (known as Wasting Syndrome).

The researchers found that in both groups the **Colloidal Silver** *was capable of killing pathogens and purging the bloodstream of germ defenses in order to restore the immune system.*"

1. First, is the *HIV / FeLV retrovirus*, which is said to attack the immune system.
2. Second, are the main outward effects, the conditions / diseases / symptoms resulting from the weakened immune system.

1. First, **Colloidal Silver** *attacks the HIV virus directly and very effectively.*

Mode of Antiviral Action of Silver Nano-Particles Against HIV-1

Humberto H Lara*, Nilda V Ayala-Nuñez, Liliana Ixtepan-Turrent, Cristina Rodriguez-Padilla

Abstract: **Silver nanoparticles** are effective virucides as they inactivate **HIV particles** in a *short period of time*, exerting their activity at an early stage of viral replication (entry or fusion) and at post-entry stages. The data presented here contribute to a new and still largely unexplored area; the use of nano-materials against specific targets of viral particles.

Background: **Silver nanoparticles** have proven to exert antiviral activity against **HIV-1** at *non-cytotoxic concentrations*, but the mechanism underlying their HIV-inhibitory activity has not been fully elucidated. In this study, **silver nanoparticles** are evaluated to elucidate their mode of antiviral action against **HIV-1** using a panel of different in vitro assays.

Results: Our data suggest that **silver nanoparticles** exert **anti-HIV activity** at an early stage of viral replication, most likely as a virucidal agent or as an inhibitor of viral entry.

Silver nanoparticles bind to gp120 in a manner that prevents CD4-dependent virion binding, fusion, and infectivity, acting as an *effective virucidal agent against cell-free virus* (laboratory strains, clinical isolates, T and M tropic strains, and resistant strains) *and cell-associated virus*.

Besides, **silver nanoparticles** inhibit post-entry stages of the **HIV-1 life cycle**.

Conclusions: These properties make **silver nanoparticles** a broad-spectrum agent not prone to inducing resistance that *could be used preventively against a wide variety of circulating HIV-1 strains*.

The Natural Remedy Book For Dogs And Cats - By Diane Stein

Dr. Gloria Dodd, DVM has had consistent success with treating *Feline Leukemia (FeLV)* for many years using **Orthomolecular, Homeopathic** and **Medical Ozone** protocols:

(N.B. **Homeopathy** is the leading "alternative medicine" treatment used by **physicians** in **Europe**. **Homeopathy** is also widely used throughout **Asia** and **Worldwide**).

However, despite her numerous successes in *reversing "incurable" Feline Leukemia ...* **Dr. Gloria Dodd** also makes it clear that ... *Feline Leukemia (FeLV)* becomes extremely difficult to treat if the animal has been on *cortisone*.

Parcell's solution is to *remove the pesticides and contaminants* from fresh fruits, vegetables and meats by soaking the food in a decontaminant solution. EAV refers to *Electro-Acupuncture*:

According to **Reinhold Voll, M.D. – Germany**, this is a method of *acupuncture therapy* as well as an accurate diagnostic. (More info: www.whale.to/c/wright1.html).

Dr. Karen Becker, DVM - "*Steroids* (also called *prednisone, cortisone* or the non-descript "*allergy shot*") are the *least optimal treatment choice* ... as they work by *suppressing your pet's immune system*."

Steroids actually *turn the immune system off*, which improves the symptoms remarkably fast but doesn't address the root issue of why your pet's immune system is over-reacting in the first place.

Not only can *steroids have a negative effect on your pet's liver, adrenal glands and kidneys*, but suppressing your pet's immune system with steroids also allows for opportunistic yeast and bacteria to grow on your pet's skin, sometimes *increasing the chances that antibiotics may be prescribed*."

Dr. Jeffrey Levy - "Corticosteroids (cortisone-type anti-inflammatory drugs) are the most abused and dangerous class of drugs. They do not cure the underlying cause of the problem, they usually make the underlying problem, "the real problem" ... worse!"

What eventually happens is that immune system becomes weak and ineffective or damaged and over-reactive and disease is pushed deeper into the body to come back stronger and more difficult to get rid of at a later date.

This is called trading ACUTE disease for long-term CHRONIC disease, and it is one reason why so many of us are chronically ill today.

Like antibiotics, steroids are one of the most abused class of drugs in the orthodox veterinarian field of medicine. At one time, they were reserved only for the extreme emergency cases.

Today, steroids are being used on the most trivial of conditions. Why? *They give the appearance of an instant miracle cure which matches the expectation level of the client.*

So, many doctors and veterinarians turn to steroids as the first, rather than the last, line of attack for their anti-inflammatory and anti-allergic effects. Steroids mimic the action of the adrenal glands, the body's most powerful regulator of general metabolism. Far from being a wonder drug, *steroids cannot cure one single condition*. All they do is suppress the body's ability to express a normal response.

One study tracked the progress of 4,993 people with rheumatoid arthritis for 15 years, monitoring their medications and subsequent health. Those who'd taken 5 milligrams to 10 milligrams of prednisone a day were twice as likely to break their hips and 2½ times as likely to develop cataracts as those who had taken no prednisone, the study says.

And those who'd taken the steroid at these low doses for three or more years were 3.2 times as likely to develop cataracts as those who had not taken prednisone, it says. Findings are being presented today in **San Francisco** at a meeting of the **American College of Chest Physicians**.

Steroid abuse can lead to serious, even irreversible health problems (for humans and animals). Some of the most dangerous among them include *liver damage, jaundice* (yellowish pigmentation of skin, tissues, and body fluids), *fluid retention, high blood pressure, increases in LDL* (bad cholesterol), and *decreases in HDL* (good cholesterol).

To give credence to this accomplishment, the FeLV testing was performed at the diagnostic laboratory at the **School of Veterinary Medicine, Washington State University**.

In United States: In 1983, the author published a professional paper: "**An Orthomolecular Approach To The Prevention and Control Of Feline Leukemia.**"

Many of the felines were afflicted with secondary *FeLV* effects such as barren queens, miscarriages, fetal resorption, and upper respiratory diseases. While on the **Mega C Plus** protocol, these conditions were eliminated.

The protocol is designed to **optimize immune function** through nutritional immunotherapy. It is important to understand and remember those cats that become *FeLV positive were immune deficient* ... the immune system is unable to fend off this "super bug."

There are some felines that are borderline; that is they have sufficient immunity to fend off the virus and will test FeLV negative, but *when vaccinated* with the leukemia vaccine, they *test positive for FeLV*. Some of these cats become symptomatic and die. It is the author's contention that some cats' immune systems cannot take the added burden of the leukemia vaccine.

Improving immune function nutritionally is not a "quick fix," it will take time. Young felines up to two years of age can turn around within three months. The older the cat the longer it will take to turn around; a five year old that has been infected most of its life may require as long as three years.

We can thank **60 Minutes New Zealand** for the following report:

... Mr. Smith made a swift and complete recovery after administration of vitamin C!!!

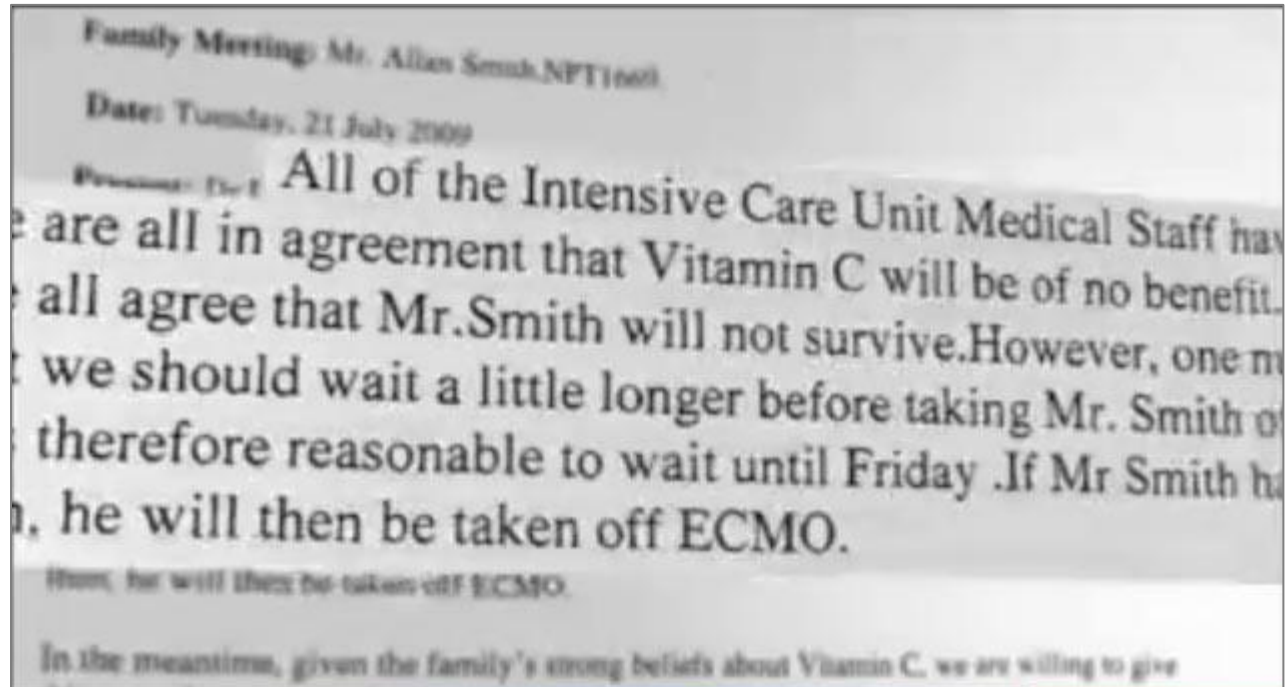

Orthomolecular medical researchers, including **Nobel laureate Linus Pauling**, have long recognized the great importance of **vitamin C in fighting cancer**. He and Scottish medical doctor - **Dr. Ewan Cameron** - published "**Cancer and Vitamin C**" in 1979.

When we take **vitamin C orally**, it will absorb in limited amounts into the body and must pass through the stomach and at about 4000 milligrams, people have what is called "bowel intolerance" (diarrhea) ... a common symptom of antibiotics and innumerable pharma drugs.

However, when we take **vitamin C intravenously**, it will flood the cells and tissues with far greater amounts of **vitamin C** ... as much as 100,000 milligrams (100 grams)! You bypass the bowel intolerance problem when you bypass the stomach ... flooding the body, cells and tissues with vital tools / nutrients it needs naturally biologically to promote healing, boost metabolic and immune function, reverse the disease process ... without any harm or toxicity to healthy cells.

We typically administer between 25 and 100 grams of **vitamin C** intravenously (in an IV).

Japan Studies – 2012

Pre-treatment with **intravenous vitamin C** and other oral antioxidants has been demonstrated once again to provide significant protection against radiation poisoning and cancer ... confirming research showing vitamin protection done nearly 20 years ago:

Dr. Atsuo Yanagisawa, M.D., Ph.D., from the **Japanese College of IV Therapy** recently conducted a study which found that Fukushima workers who underwent a **high-dose vitamin C** pre-treatment prior to handling radioactive debris during cleanup efforts were protected against **DNA damage and cancer**.

Dr. Yanagisawa evaluated men between the ages of 32 and 59 that worked between five and six weeks in a **high-radiation area** of **Fukushima, Japan**. After taking blood samples from all the men and evaluating for whole blood count and chemistry, and plasma levels of free **DNA and 47 cancer-related gene expressions** ... **Dr. Yanagisawa** and his team found that those who received the mega dose **intravenous vitamin C** therapy experienced no increase in cancer risk or change in free DNA.

Those who did not receive the treatment ... had significantly increased cancer risk.

Those who did not receive pretreatment, but that received a post-treatment intervention with the same regimen (mega dose **intravenous vitamin C** and oral anti-oxidants) for two months, however, saw their heightened free DNA levels return to normal.

Their overall cancer risk score also returned back to normal, illustrating the incredible power of **vitamin C** and other antioxidants to protect against, and even reverse, the damage caused by radiation.

Part 7

“The Artemisinin Cure”

VS

Cancer and Leukemia

So far, the most extensive study on the use of **Artemisinin** as an anti-cancer agent was carried out by bioengineering scientists **Dr. Narendra Singh** and **Dr. Henry Lai** of the **University of Washington, U.S.**

The following study was reported in the *Journal Life Science (70 (2001): 49-56)*:

In laboratory studies of chemo radiation on *resistant breast cancer cells*, revealed that artemisinin has *75 percent cancer cell killing properties in 8 hours* and *almost 100 percent killing properties within 24 hours* when these cancer cells are "pre-loaded" with iron after incubation with holotransferrin ... on the other hand, the normal cells remained virtually unharmed by the non-toxic artemisinin.

Another study showing the effectiveness of **artesunate** in treatment of cancer was also published in *Oncology (April 2001: 18(4): 767-73)*:

The fact that iron content of cancer cells is high has also been used in another anti-cancer therapy called *Zoetron therapy*, where iron containing cancer cells are induced into motion using a magnetic device to induce resonance. Resonance generates heat. Cancer cells are more sensitive to heat compared to normal healthy cells. When cancer cells are heated to a certain temperature, they die while normal cells survive.

Artemisinin is effective against a wide variety of cancers as shown in a series of successful experiments:

The most effective is *leukemia* and *colon cancer*. Intermediate activities were also shown against *melanoma, breast, ovarian, prostate, CNS* and *renal cancer*. Although artemisinin is insoluble in water, it is *able to cross the blood brain barrier* (water soluble artesunate is the weakness among the derivatives) ... and may be particularly suitable for *curing brain tumors*, together with *Poly-MVA (a metalo-vitamin)*.

In addition to the high affinity for iron in aggressive cancer cell types, most cancer cells also lack the enzyme catalayse and gutathione peroxidase. Catalayse breaks down *hydrogen peroxide*. A low catalayse content means a higher *hydrogen peroxide* load, which can release *superoxide* free radicals when properly stimulated to do so.

This is in fact one common mechanism among chemotherapeutic agents as well as **vitamin C**. These traits make cancer cells more susceptible to oxidative damage as compare to normal cells in the presences of hydrogen peroxide. For this reason, *administration of vitamin C in high dose is acceptable, although a gap of 2-3 hours is preferred*.

Dr. Rowen, a naturally oriented U.S. doctor and editor of the medical newsletter "*Second Opinion*", says the **Hoang family of physicians in Vietnam** has used **artemisinin** in the treatment of cancer for years:

They have reported that, over a 10-year period, more than **400 patients** were treated with *artemisinin* in conjunction with a *comprehensive anti-cancer program* with 50 to 60 percent *long-term remission rate*. The safety record of *artemisinin* has well been **studied for over 25 years**. No significant toxicity in short-term use for malaria at high dose of up to 70 mg/kg per day has been reported.

Artemisinin is not a stand-alone chemotherapeutic agent. A combination of nutritional supplements (such as *green tea, CoQ10* and *pancreatic enzyme*) as well as a good anti-cancer diet is required.

1. Many of the pharmacological principles currently used as anti-cancer agents were first isolated from medicinal plants throughout the world. Important anti-cancer agents are extracted from plants because they cannot be synthesized chemically on a commercial scale due to their complex structures that often contain several chiral centers.

The aim of this study was to test different extracts from the leaves of **Moringa Oleifera** for activity against *leukemia* and hepatocarcinoma cells in vitro.

The extracts could kill majority (70 - 86%) of the abnormal cells among primary cells harvested from 10 patients with *acute lymphoblastic leukemia* (ALL) and 15 with *acute myeloid leukemia* (AML) as well as a culture of hepatocarcinoma cells (75% death).

In conclusion, **Moringa oleifera** may have potential for use as source of natural treatment for diseases such as cancer and *leukemia*.

2. The present study was aimed at investigating **Moringa oleifera plant** leaves and the effects of its crude extract *anti-leukemia* activity on *leukemia cells*. Several secondary metabolites are present in **Moringa oleifera** as the plant serves as reservoirs for various bioactive compounds.

Ethanollic extracts killed about 36% of abnormal cells among primary cells harvested from 3 patients with *acute myeloid leukemia* (AML) and hepatocarcinoma cells HpG2. These results provide in vitro evidence and support the traditional use of **Moringa oleifera leaf** as a potent source of *anti-cancer*.

3. Mice with the fatal cancers were treated with **moringa olifera extract**, while other mice with cancer were left untreated as a control group; another group of healthy mice was treated with **moringa** as were the sick mice as a second control group.

The mice treated with moringa survived and appeared to have lost their tumors. Within a month, they went from sickly looking to healthy looking with shiny coats ... The mice not treated with the moringa died.

*The healthy mice who were administered **moringa** became more active, appeared younger as evidenced by the color of their fur and generally appeared even healthier.*

To even suggest that the medical establishment’s approach to chronic disease is completely wrong is sacrilege. I’ve witnessed the close-mindedness and absolute refusal to consider facts first hand among some former MD friends I once had.

However I know they should not be inherently blamed for their ignorance on the fact that they are used as status quo gatekeepers and public authority figures put in place by a system that has been thoroughly implanted to protect the flow of profit at all costs.

They can be blamed however, for never considering, researching and looking into information that contradicts their “professional training”. For this, we all suffer the consequences.

They are wonderful at emergency room surgeries and putting you back together after becoming mangled in a car crash, but for treating chronic disease they are abhorrently misinformed, enabling ... and a big part of the problem.
